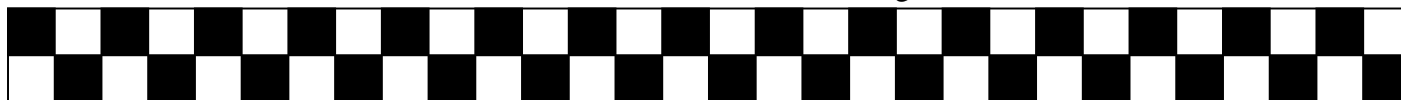

## FAQ Column

**Registration** - Credential Center is (again) at the Hilton Hotel Lobby – 1<sup>st</sup> Street between 3rd & 4<sup>th</sup> Ave S. There will be limited 15 minute Parking allowed in this area. To help avoid parking problems at the Hilton, we will also offer rides from our Compound to registration as a convenience beginning Thursday afternoon.

**Credentials:** You must apply online at the CFR website ([www.cfrscca.org](http://www.cfrscca.org)) under 'Pro Racing', and be approved by your specialty chief in order to participate. The Official Credential for this Event will be the CFR Race Control, Hard Card, Photo ID. If you do not have one, it will be issued. If yours is out of date, it will be renewed at the Event. In either case, you must present your "current" SCCA Membership Card and Specialty License in order to receive a Validation Sticker. There are no exceptions to this rule. Please Don't ask.

**Worker Parking** – The CFR Compound is at the Port of St. Petersburg located at 250 8th Ave SE. Parking in the compound will be tight. Car pooling will help us make the most of it.

**Shuttles** – CFR will provide On-Track Shuttles.

**Overnight Parking** - Limited overnight parking is available in the Port Compound. Details at Registration.

**Meetings** - Staff Meetings will be held at 6:30 AM each morning in our Port Compound. **BREAKFAST items** (coffee, juice, pastry, fruit) will be provided!

**Meals** – In addition to a (cold) Breakfast, CFR will provide lunches and snacks on station during 'hot' circuit hours. Our 'Welcome Gathering' will be held Thursday evening at Ferg's Sports Bar. Our Friday Social and Saturday Dinner will be conducted at the Port compound.
